Eligibility:

1. Undergraduates must be senior standing with a business concentration in the School of Business at Indiana University Kokomo.
2. Graduates must be enrolled for a minimum of six-credit hours in the MBA program at Indiana University Kokomo.
3. Must be a Howard County resident.
4. A one-page (or less) essay entitled: "Why I Should Be Named The Recipient of the Bucheri, McCarty & Metz Scholarship."

Terms:

1. Must be enrolled in the School of Business at Indiana University Kokomo.
2. Scholarships are to be used exclusively for educational expenses.

Business and Economics General Scholarship

The **Business and Economics General Scholarship** is designed to recognize excellence and superior scholastic performance. The amount of the scholarship is \$500. One scholarship will be awarded per year.

Recipients will be carefully selected on the basis of their academic achievements, co-curricular activities and recommendations. Financial need will not be a factor.

Eligibility:

1. Must be junior or senior standing in the School of Business at Indiana University Kokomo.
2. Overall G.P.A. must be 3.0. Must have 3.5 G.P.A. in business and economics courses.
3. Must not have been a recipient of this award in a previous semester.

Terms:

1. Must be enrolled at Indiana University Kokomo.
2. Scholarships are to be used exclusively for educational expenses.

Patricia Pencek Endowed Scholarship

2. Must have a minimum GPA of 3.0 out of a 4.0 scale.
3. Must be a resident of Howard County and/or contiguous counties (Carroll, Cass, Clinton, Grant, Miami, and Tipton)

1. Must be enrolled in the School of Business at Indiana University Kokomo.
2. Scholarships are to be used exclusively for educational expenses.

Sita C. and C.L. Amba-Rao Undergraduate Service Award

The **Sita C. and C.L. Amba-Rao Undergraduate Service Award** is donated by Professor Sita Amba-Rao and is awarded annually. Candidates should have a record of academic excellence as demonstrated by a cumulative of at least 3.2 on a 4.0 scale and hold junior or senior standing. In addition, students should demonstrate managerial and leadership potential through participation in campus and community organizations. Student must be enrolled in the School of Business at Indiana University Kokomo and be a Management and Human Resource (or Management and Administration) major. The amount of the scholarship is \$500.

Recipients will be carefully selected on the basis of their academic achievements and co-curricular activities. Financial need will not be a factor.

Eligibility:

1. Must be junior or senior standing.
2. Must be enrolled in the Management and Human Resource (or Management and Administration) concentration in the School of Business.
3. Overall G.P.A. must be at least 3.2 on a 4.0 scale.
4. Must demonstrate managerial and leadership potential through participation in campus and community organizations.

Terms:

1. Must be enrolled at Indiana University Kokomo.
2. Scholarships are to be used exclusively for educational expenses.
