Assessment Plan

Formative Evaluation of Program Learning Outcomes and Program Elements

The systematic assessment plan for the Indiana University Kokomo School of Nursing and Allied Health Professions master's programs emphasizes formative and summative assessment of course student learning outcomes, program student learning outcomes, program outcomes and includes Accreditation Commission for Education in Nursing (ACEN) standards.

Faculty are required to provide evidence of meeting course learning outcomes/competencies through assessment and evaluation of student artifacts mapped to course student learning outcomes and competencies. Evaluation of learning outcomes from each course is based on best practices such as rubrics, portfolios, and self-reflection. The faculty member reports student attainment of course learning outcomes to the MSN Evaluation Committee for course review. The committee may accept the recommendations or make additional changes to the course. This information is also reported by faculty in their annual report to show growth towards excellence in teaching. This procedure provides a consistent method for faculty to evaluate how they met course-learning outcomes and thereby measure teaching effectiveness. While student evaluations are important, SNAHP feels it is essential to include data other than student evaluations in the assessment of teaching effectiveness.

Summative Evaluation Components

The IUKSNAHP MSN Assessment Plan also includes evaluation of student learning outcomes and program student learning outcomes. The evaluation of student learning outcomes consists of the following: 1) Course/Student Learning Outcomes and 2) Preceptor Evaluation. For the evaluation of the program outcomes, data will be collected from the following: 1) program completion rates, 2) graduate satisfaction survey, 3) employer satisfaction survey, and 4) student employment in the area of professional practice. 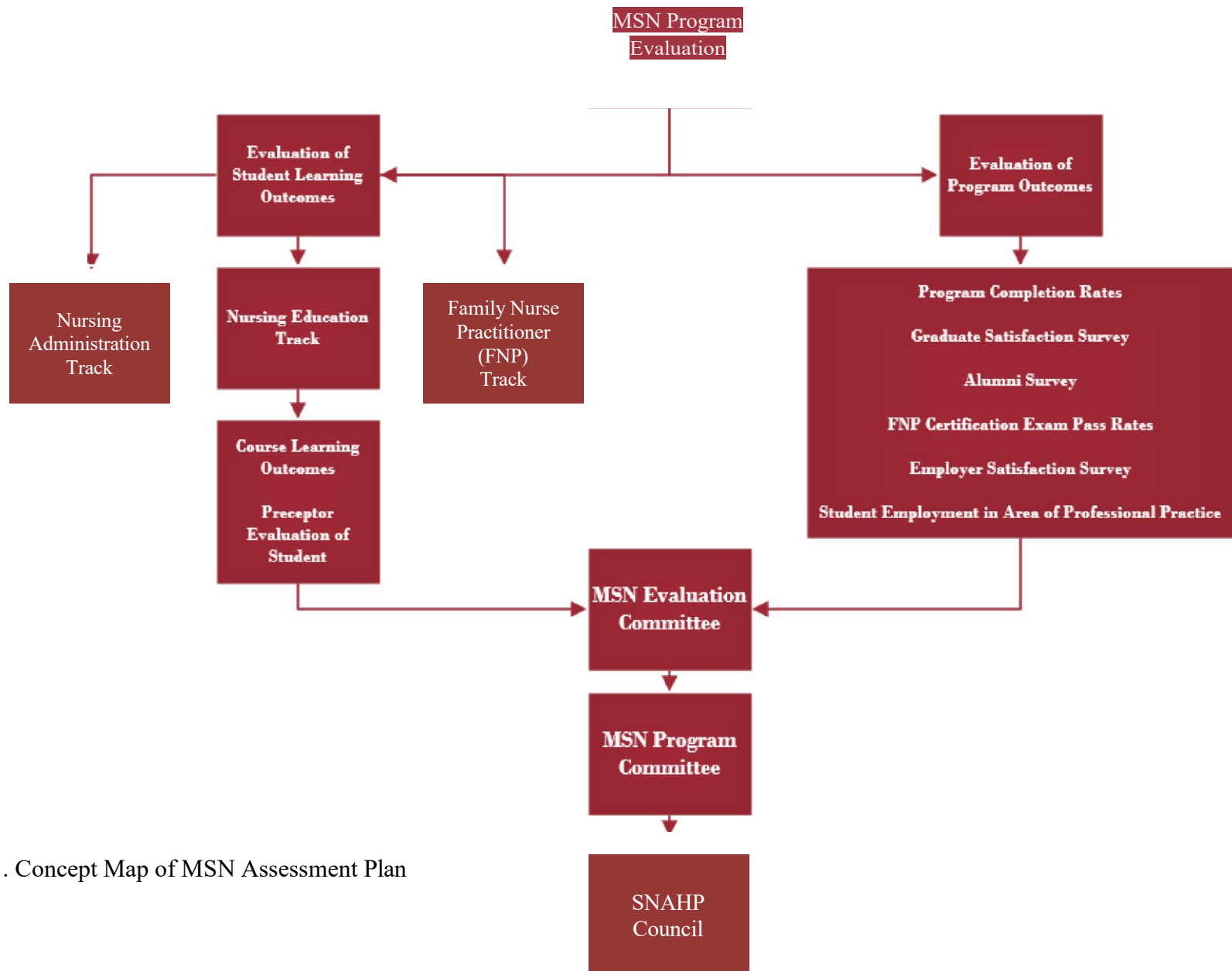


Figure 1. Concept Map of MSN Assessment Plan

Program Elements

Additional data may be collected to evaluate program elements. For example, additional surveys and focus group data are collected and reported to the MSN committee for recommendations, possible changes, and implementation. For example, the program director visits class during the semester to talk with students about problems or concerns to evaluate program effectiveness and solve issues promptly. Another example, one year into the program, a survey was given that measured students' perception of the MSN culture. Before beginning the MSN program, faculty defined the graduate culture to guide and enhance the SNAHP program mission.

Evaluation of Course Learning Outcomes

- 1. Course/Student Learning Outcomes:** Student Learning Outcomes are a pivotal part of student learning. The learning outcomes paired with course assignments allow students to create meaningful connections between the assignment and the necessity or the “why” for completing such. Therefore, faculty assigned to teach the course are responsible for submitting a Student Learning Outcome document at the end of every semester to ensure consistent tracking of student learning outcomes and End of Program Student Learning Outcomes (EPSLO). For EPSLO, Instructors collect data from rubrics aligned with EPSLOs and report results in the SLO document. Plans for future offerings are articulated in the SLO document, focused on improving student learning outcomes and/or end-of-program student learning outcomes. The Evaluation Committee reviews recommended changes. Changes that affect the MSN curriculum are sent to the Curriculum Committee for review.
- 2.** Each semester the SLO’s are reported out by the course instructor to the Evaluation Committee. The committee, along with the course instructor discusses areas of strength and possible areas for improvement within each course. The table below identifies and links the reader to the gaps noted in the learning evaluation. To examine the deficit in greater need click on the course number and review the document noted. A comprehensive document containing all SLO’s for all courses in the MSN program.
- 3. Preceptor Evaluation** Preceptors will provide feedback to students at the end of their practicum experience using separate instruments mapped to competencies for each track. The preceptor works with the student to meet student learning outcomes for T679 Nursing Education Practicum and L579 Nursing Administration Practicum. The Family Nurse Practitioner preceptor feedback is based on NONPF criteria. This preliminary appraisal provides feedback to the faculty from the student about the preceptor and from the preceptor about the student.
- 4. Pass Rate:** Eighty percent or more who take a certifying examination appropriate for the FNP pass on the first attempt.
- 5. HESI:** The HESI Family Nurse Practitioner (FNP) Exam is a comprehensive test developed that evaluates the knowledge, skills, and abilities needed to become a successful Family Nurse Practitioner. The exam consists of 150 multiple-choice questions that cover topics such as health promotion and maintenance, diagnostic reasoning, clinical management, and professional issues. The exam also includes a comprehensive review of the core content areas of the family nurse practitioner role, including primary care, pharmacology, and physical assessment. The HESI FNP exam is designed to

assess the competency of individuals who are near graduating a Family Nurse Practitioner program and are ready to begin practice. Given in December prior to May graduation. Scores are utilized to identify levels of competency. Each student is required to create a remediation/study plan to meet individual needs and increase competencies.

Evaluation of Program Outcomes

As stated previously, the evaluation of program outcomes includes data collected from the following: 1) program completion rates, 2) exit satisfaction survey, 3) alumni survey, 4) certification exam pass rates (FNP), 5) employer satisfaction survey, and 6) student employment in the area of professional practice.

1. **Program Completion Rates** Sixty percent of the MSN students who attend class on the first day of the first course in the program will complete the program exactly on time (in six semesters for Nursing Education and Nursing Administration; in seven semesters for FNP).

Eighty percent of the MSN students who attend class on the first day of the first course in the program will complete the program within 150 % of the exact program length (in six semesters for Nursing Education and Nursing Administration and nine semesters for FNP).
2. **Exit Satisfaction Survey** Near graduation, students of all MSN tracks are emailed that includes self-report items for every program student learning outcome. A 4 point Likert rating scale is used. Currently benchmarks are set at achievement of a mean of 3.0 or higher in all areas.
3. **Alumni Survey** Within one year after graduation, alumni of all MSN tracks are emailed a survey similar to the exit survey though somewhat shorter, that includes self-report items for every program student learning outcome. A 4 point Likert rating scale is used. Currently benchmarks are set at achievement of a mean of 3.0 or higher in all areas.
4. **Certification Exam Pass Rates** Certification exam pass rates pertain to FNP only. Benchmark: Certification exam pass rates pertain to FNP only. Eighty percent or more who take a certifying examination appropriate for the FNP pass on the first attempt.
5. **Employer Satisfaction** SNAHP will survey employers of MSN graduates regarding graduate preparation for their work setting, overall satisfaction, and the quality of their performance as employees. In addition, employers will be surveyed at the annual advisory council meeting of all hospital and nursing program representatives. Benchmark: 80% or more of respondents of employers will express satisfaction with the program.
6. **Student Role-Related Professional Practice** Our program outcome goal is that 60% of graduates seeking employment will be involved in role-related professional practice or doctoral education at one-year post-graduation. Data is collected from the Alumni Survey.
7. **Diversity** In efforts to align with the AACN Essentials focus on DEI, the MSN program has mapped objectives to the curriculum. These competencies will be measured within courses just as other course learning competencies.

With the return to face-to-face courses provided solely by IU Kokomo MSN faculty, review course curriculum and evaluation changes made when entering the consortium. Consider revisions as needed to strengthen cohesion across core and track courses.

Considerations for the future:

Standardized syllabi. Syllabi were displayed in various formats. PLO and SLO also displayed and reported in different formats. Consider standardizing to ease reporting out.

Many courses were mapped to every outcome. While content may stretch across entire program, consider being more selective with PLO's that are reflective of each course.

Since implementing the changes listed below, all learning outcomes have been met.

After reviewing the 2025 report, we find that all program learning outcomes are met with some exceptions. Gaps were discussed within the Evaluation Committee meeting.

Major curriculum revisions have occurred across all tracks within the MSN program to meet the call for change set forth by the AACN essentials. Over the course of implementing the new essentials, competencies will be measured across all tracks.

We moved into the new curriculum and collaborative program across Indiana University and then became a face-to-face program once again, decided in early 2026. The SLO data from 2025 includes data from teach out courses, online consortium courses, as well as face-to-face continuing courses.

The committee will continue to evaluate courses per faculty evaluation of "meeting course student learning outcomes" and make changes as recommended or approved by the committee.

Dissemination of Results:

This report will be distributed to all regular MSN faculty members prior to MSN Committee Meeting for discussion, possible curriculum revisions and subsequent recommendations for changes. A final report will be submitted for review to the Indiana University Kokomo School of Nursing and Allied Health Professions MSN committee. In addition, at an advisory board meeting in we will share a short report of these findings. Also, for dissemination to all stakeholders, we put a copy of the report (PDF) on the IU Kokomo School of Nursing and Allied Health Professions website.
